Description of corner evidence found and/or method applied in restoring or reestabl ishing corner: R.

Standard Section Corner common to Sections 23 & 24, T7NR4E, Venice Township, Shiawassee County Found no evidence of original government corner or county survey record at the location of this corner. Found PK nail 10.8' East of the physical centerline of State Highway M-13, considered lost and placed by single proportionate measure. The corner M-8 is not shown on the M-13 right of way plan or construction plan, so no comparison can be made. A prorated position of M-8 using the 1876 county survey by Mason would fall 3.2' South of the found PK. Using the angle as measured by Elliot of 179°35' at this position would place it further West 9.6 feet, which would fit the centerline of M-13 comparatively with the other standard corners North and South of M-8.

The calculated position of M-8 using the angle turned by Elliot and the Mason proration N-S appears to re-establish the position of the Mason corner quite well. The angle measured from K-8 to M-7 from this position is 91°33'57" (Mason 91°35'); the angle from M-9 to K-8 measured 88°51'04" (Mason 88°40'); the angle from this position to L-7 at M-7 measured 88°34'30" (Mason 88°35'). Measured West to L-8 (found pipe) = 2634.27' (Mason 2624.99'), to M-9 = 2637.15' (Mason = 2636.09') and to M-7 = 2637.43' (Mason = 2642.64'). We did not use this position.

We recovered the monumentation from the vacated plat of Long's addition and found the Northeast corner of the plat of Post's addition. The monuments recovered along the highway right of way measured 60' to the physical centerline of State Highway M-13. From said Northeast corner of Post's addition we measured East 61.75 feet and extended a line Northerly from M-9 through this point to establish the final position of M-8 at the Northing of found PK, as suggested by the Shiawassee County Peer Review Group. From this point we intersected the monumented North line of the 1958 survey for Long's subdivision with the Section line from calculated M-8 and M-7. From this position we measured West to the Northwest corner of Long's addition as monumented = 1312.65', Long's Addition = 1312.74'. The distance from the calculated intersection of the monumented North line of Long's addition survey and the calculated Section line to the found monument at the Northeast corner of Long's addition field notes = 60.92', Elliot notes = 60.94'. The recovered monuments along the West line of Long's addition of produce a bearing of N00° 12'02"E, and the measured bearing of M-9 to calculated M-8 is N00°01'34"W, a difference of 13'36". The plat of Long's Addition shows a difference of 00°11'00", West line = N00°46'00"E, Section line = N00°35'00"W. The monumented South line (Also North line of Posts Addition measured 1316.48' (F.A. Gould = 1317.25', Long's Addition = 1317.00' and Calculated center of SE 1/4 to the intersection of the monumented South plat line and the calculated East Section line = 1316.81). We believe that the existing monumentation, is evidence of the position of the corner M-8 and should not be considered a lost corner. We recommend accepting the calculated position, as approved by the Shiawassee County Peer Review Group, of M-8 as a careful and faithful re-establishment of the position of the original government comer and place a custom Shiawassee County Harrison monument, consisting of a cap welded to a 5/8" X 2.5' re-
