## A. Description of original monument and accessories and/or subsequent restoration:

Nov. 17, 1834 Hervey Parke, D.S. Ran the East line of T12N-R9E and at 480 chains North of SE cor. Sec. 36, T12N-R9E set a temporary post but gave no witnesses. Nov. 22, 1834 Hervey Parke, D.S. ran the South line of T13N-R10E and at 476.33 chains intersected range line 4.50 South of temporary post bearings - Pine 20" N19°E 24 links and Tamarack 9" S13 1/2°W 37 links. Dec. 26, 1834 Hervey Parke, D.S. ran the South line of T13N-R9E and began at the post corner T12 & 13N-R9 & 10E, bearings - Pine 20" N19°E 47 links, Tamarack 9" S13 1/2°W 37 links. May 28, 1678 Bare 18 by Power 1 S #11102 End E/0" no mod w/ton 10" bont over 1811 where it 1978, LCRC Page 18 by Rowe, L.S. #11192. Fnd. 5/8" re-rod w/top 10" bent over. Held where it goes straight.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Found 5/8" iron rod, crockery, china, green glass and clear glass buried at site around 5/8" rod. Found one accessory that indicates the corner found is in the same position as the 1978 L.C.R.C. Accepted 5/8" iron and buried objects (noted above) as the best evidence of the original corner.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Removed 5/8" iron rod and placed concrete monument with standard brass cap stamped M-13, T13N-R9E. Replaced disturbed pieces of crockery, china and glass around monument. N70°W 31.15' fnd. spike in SW face 10" Poplar.

S85°W 55.75' set T.C. Remon. tag & spike in N. face of cluster of 5 - 4" to 8" Maples. N80°W 41.41' set T. C. Remon. tag & spike in N. face of cluster of 4 - 6" to 12" Maples. N40°E 42.94' set T. C. Remon. tag & spike in SE face of p. pole.


