B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Found 1" pipe in place and two accessories that indicate the corner found is in the same position as the 1991 survey. Accepted 1" pipe as the best evidence of the original corner.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Removed 1" pipe and placed concrete monument with standard brass cap stamped B-13, T12N-R10E.


