FOUND 1/2 IN. DIA. RE-ROD INSIDE CAST IRON PIPE BELL--MEASURED DEFLECTION ANGLE AND LINEAR MEASUREMENTS TO SECTION CORNERS NORTH AND SOUTH CONFIRM FOUND MARKER TO BE IN SAME POSITION AS 1973 SURVEY OF DODGE ROAD.

NOTE: FOUND LONG STANDING OCCUPATION EAST FROM THIS CORNER (REMAINS OF FENCE LINE); FIELD DIVISION IS TO WEST,

ACCEPTED FOUND PIPE AND RE-ROD AS A CAREFUL AND FAITHFUL PERPETUATION OF ORIGINAL GOVERNMENT CORNER.


