A. Description of original monument and accessories and/or subsequent restoration:

1830 - G. Harrison D.S. ran North between Section 27 & 28 and set corner post, accessories: 5" W. Oak N. 21 deg. W. 15 Lks; 4" W. Oak N. 37 deg. E. 22 Lks. 1898 - C. Mutchler C.S. found stake after being told by local resident, of 40 to 50 years, where to look. Mutchler measured North 2659.14' to quarter cor. 1948 - T.A. Smith C.S. measured 2567.0 feet between S.E. cor. & S. 4 cor. of Sec. 21.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Original corner or accessories not recovered. Found  $\frac{1}{2}$ " (I.D.) pipe as referenced in Surveys recorded: L.2, P.13; L.3, P.48 & P. 205; L.7, P.112 & P.194. Recent measures indicate S.W. Cor. Sec. 22 to W. 4 cor. at 2659.88 feet and S.E. cor. Sec. 21 to S4 cor. at 2568.09 feet. Found pipe was ratified by Van Buren County Remonumentation Peer Group on Nov. 17, 1993 and is accepted as a careful and faithful perpetuation of the position of the original corner.

Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Dug and removed existing 1 pipe, found no additional evidence of a corner down to 30" deep. Placed standard 30" Harrison Monument. Witnessed by: Nail in West face 10" Oak NORTH 54.92'; Nail in West face 18" Oak S. 10 deg. E. 16.65'; Nail in West face 18" Oak S. 5 deg. E. 37.50'; Nail in South face West branch twin 15" Cherry N. 80 deg. W. 59.00.
