

## A. Description of original monument and accessories and/or subsequent restoration:

## B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

I-4) West corner section 11, T.3 S., R.8 E., Van Buren Township

Found a steel cased concrete monument with an iron pipe 1" below gravel road surface (intersection of Morton Taylor and Robson Road). Verified corner location by comparing W.P.A. data with field measurements:

I-4 to I-3 Record = 2665.93' Measured = 2666.02' I-4 to I-5 Record = 2659.32' Measured = 2661.36'

Angle line I-4 &amp; I-3 to I-4 &amp; I-5 Record = 179°-43'-10" Measured = 179°-43'-43"


## C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

I-4) West corner section 11, T.3 S., R.8 E., Van Buren Township

Found a steel cased concrete monument with an iron pipe 1" below gravel road surface (intersection of Morton Taylor and Robson Road). The selected location is accepted by the contractor and is generally accepted by professional surveyors as the best available evidence of the position of the corner. WITNESSES: Set nail WCR tag NW face 18" Elm N.51°52'08" E. 68.59', found PK nail SE face DE pole S.48°42' 56" E. 42.42', found PK nail and tag #19837 N face power pole S.49°00' 53" E. 42.13', found PK nail & WCRC tag N face power pole S.64°32' 50" W. 75.96', found PK nail and tag #19837 N face power pole S.64°33' 13" W. 75.96', found cut cross NW rim sanitary MH N.54°14' 38" W. 44.68', found cut cross W flange bolt HYD N.45°11' 24" W. 65.57', top bolt HYD N.44°48' 42" W. 65.43'.
