Deed's Record of Survey distances and with occupation in the Northeast 1/4 of Section 1, T22N, R10W as set by 1901D.E. Teed's Record of Survey. This corner is accepted as a careful and faithful re-establishment of the position of the original corner, being the quarter corner common to Section 1, T22N, R10W and Section 6, T22N, R9W.
