

A. Description of original monument and accessories and/or subsequent restoration:

1837 GLO Quarter Section post by John Brink, Deputy Surveyor, Birch 16" for Quarter Section corner 1891 A.J. Teed Survey in Section 18, T22N, R9W, Liber 1, Page 140, Beech 14 N 47½°E 52 Hemlock 14 S 29° W 61 marks on birch plain and ok.

1895 A. J. Teed Survey, Liber 1, Page 182, corner found no description given, Elm 14 S 53° E 20, Sugar S 36° W 27 1907 Devoe Survey in Section 18, T22N, R9W, Liber 1, Page 141, tele. pole N 31° W 53 (gas pipe)

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Found Wexford County mon. in monument box ±3' West of centerline road North-South, corner position matches closely with 1907 Devoe Survey, distances to North and South. This corner is accepted as a careful and faithful perpetuation of the position of the original corner, being the 1/4 corner common to Section 13, T22N, R10W and Section 18, T22N, R9W.
