- I-4 1/4 Corner common to Sec. 10 & 11 Corner position in Manistee River as noted by Teed and Fargo. Searched for Teed stake 25 Links N. of corner in river but could not find it. Teed wit. cor. position would also appear to be in river now. Fd. 3/4" x 1.9' hooked end pipe w/ 2 Butter dishes on S. Bank of River for Witness Corner noted by Fargo. Calculated 'I-4' corner position in river by projecting E. line of Sec. 10 from 'I-5' (calculated Fargo proportional position in Manistee River) N2°11'39"E 2527.69' (2527.47' – FE) to and through Witness Corner at N2°11'39"E 102.81' (102.8' – FE) to 'I-4' in River. From 'I-4' (in river) N2°22'34"E 2626.11' (2630.27' – Fargo) to 'I-3'. Also set POL's at N2°22'34"E 50.00' on Sec. line to North of 'I-4' and S89°19'42"E 465.0' of 'I-4' on E-W 1/4 line of Sec. 11.
