- E8 1/4 Corner common to Section 20 & 21, T24N, R10W
  - 1852 GLO Resurvey L. S. Scranton Set Hem. Post
    - 1) W. Pine 18" S49°W 20 L.; 2) Y. Pine 18" N40°E 22 L.
  - 1913 Fargo Engineering Found stumps of both U.S. witnesses with hack at bottom. Also found point of very old stake beneath surface at proper distance and bearing. Set iron post and crockery.
  - 1) W. Pine stump 24" S50°W 20; 2) Y. Pine Stump N38°30'E 21 1/2.
  - 1937 Random line by F. Clark for Schaaf. S2°30'W 47.03 Intersect ¼ Cor. 6.14 E. of post.
  - 1937 M. Schaaf (PS # 3401) Found both stumps of witnesses.
  - 1962 K. J. Ostling (PS # 10068) LCRC L. 3, p. 44 (1977) Found 1½" pipe and old stake at corner as set by Marcus Schaaf RLS about 1940. Corner previously restored by Fargo Eng. for Consumers Power Co. in 1913 at which time they found point of old stake and remains of both U. S. witnesses which are still in place. Corner falls at fence corner N-S-E and checks very well with stream North. Set 1" pipe with 4" Brass Cap.

## Part B: Surveyor's Report on Perpetuation, Restoration, Reestablishment, or Monumentation of Corner

E8 – ¼ Corner common to Sections 20 & 21, T24N, R10W.

Found 4" Dept. of Conservation Brass Cap on 1" iron pipe. Falls in N-S fence line. Wood post line to east. Trace of single strand to West. Centerline of N-S 2-track is 8.5'± East. Condition of witnesses as follows: #1 – Remains in place; #2 – gone; #3 – OK – 153.8' to centerline 26"; #4 – gone; #5 – gone; #6 – OK; #7 – Stump remains.

DOC Monument accepted as a careful and faithful perpetuation of the position of the original corner.
