

<u>|</u> 1/4 Corner common to Section 20 and 29 – Fd. 3/4" x 2.5' long iron pipe w/ hooked end per Fargo Eng. in overgrown E-W two-track. Fit remains of Fargo's NW BT. Removed pipe and find remains of wood post, one butter dish and five broken pieces of another Butter dish alongside pipe. Fargo set pipe by single proportion. Fargo pipe accepted as a careful and faithful reestablishment of the position of the original corner.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

<u>- 60</u> Replaced Fargo pipe with 4" DNR Aluminum cap on 1" x 36" Galvanized iron pipe with 1' of 4" PVC with concrete around cap Placed five pieces of broken crockery at base of monument as memorial.
