Found 1" iron pipe badly bent to the east and 1" below crushed limestone surface of Arkona Road.

Excavated to a depth of 6" and found a disturbed nail on the west side of the iron. The iron appeared to straighten out here and I witnessed the apparent center to four P.K. nails set at three feet in the cardinal direction. Hole size, 18" x 18".

Excavated to a depth of 14" and found broken brick and bits of iron which appear to be broken mushroom from the top of the pipe. The pipe takes a slight bend to the southwest.

Excavated to 18" and found the top of unbroken brick and stone. I removed the pipe to find it closely resembles a dog's hind leg and has a total length of 25".

The bottom of the hole, left after the pipe was removed, was 0.09' south and 0.12' west of our witness location of the apparent center at a depth of 6".

Making note of the witness measurements to the bottom of the hole left by the pipe, I set a 1" \times 24" iron pipe and Washtenaw County Remonumentation cap stamped #37277, the top of which is 7" below surface.

On December 27, 1993, while making a preliminary inspection of this corner location, I found the north R/W iron pipe, 1" x 24", was on the surface, S.W. 10'. Plowed out this past fall. I also found an old "chain drive gear", of the kind typically found on old farm machinery, at a depth of 1' and 33'± north of the bent corner.

I set the instrument on the remonumented corner and backsighted the 1" iron pipe for the south R.W. which measured 33.02'. I extended this line north 33' and excavated carefully to a depth of 18" upon finding pieces of rusty iron flakes that look like those remaining on the iron I found lying on the surface. I reset this same iron at 33.00' and drove it so it's top is 14"± below the surface. I then placed the old "chain drive gear" around the pipe and backfilled the hole.

Measured West 2655.55' corner common 27, 26 and 34, 35.
